



**BOARD OF SELECTMEN MEETING MINUTES**  
**Wednesday November 8, 2023**

1. **CALL TO ORDER** – A meeting of the East Granby Board of Selectmen (BOS) was held on Wednesday November 8, 2023 at the Town Hall Meeting Room. First Selectwoman Wimpfheimer called the meeting to order at 6:38pm. Selectman Hall and Selectman Oliva were present.
