Total estimated cost of the project \$130,000. Seconded by First Selectman Hayden. Motion Approved Unanimously.

- **a.** Close Year-end Capital Accounts Selectman Ziobro made a motion to close the Floydville Bridge Capital Account and the Police Radio Capital Account. Seconded by First Selectman Hayden. **Motion Approved Unanimously.**
- b. Potential FY17 Capital Items for Town Meeting- First Selectman Hayden reviewed the Police Radio Quote and Road Maintenance information with the BOS. Selectman Ziobro made a motion to recommend for Board of Finance and Town Meeting approval the purchase and installation of police radios for a sum not to exceed \$35,000 from the Capital Non-Recurring Fund. Seconded by First Selectman Hayden. Motion Approved Unanimously.

- Selectman Ziobro made a motion to recommend for Board of Finance and Town Meeting approval, a sum not to exceed \$145,000 for road maintenance from the Capital Non-Recurring Fund. Seconded by First Selectman Hayden. **Motion Approved Unanimously.**
- **c. Draft FY16 Department Transfers** First Selectman Hayden reviewed with the BOS potential FY16 department transfers that he will provide to the Board of Finance at their June 14, 2016 meeting. These draft numbers may change slightly when finalized.
- **d.** Change Time for June 22nd Meeting of BOS to 5:30 pm- First Selectman Hayden will attend a Girl Scout Gold Award Ceremony in honor of Holly Corcoran and requested that the BOS meet at 5:30 pm on June 22nd.
- **e. Potential FY16 Year End Town Meeting.** There will be a Special Meeting of the BOS held at 8 am on 6/15/2016 at the Town Hall to set the Town Meeting Date and to approve the Call.
- **f. Resignations** Selectman Ziobro made a motion to accept Leo Stemp's resignation as P&Z Alternate and thanked him for his service. Seconded by First Selectman Hayden. **Motion Approved Unanimously.**
