1) Call to Order

Motion: A motion was made by Lee Sandora and seconded by Jim Francoline to accept the minutes of the January 16, 2018 meeting. **All votes were in favor and the motion carried.**

5) New Business

A) Review 2017 Grand List Data

The 2017 Grand list was reviewed. Dave Kilbon noted that the net Grand list increased .08% from the prior year.

B) Review and Discuss Revenue and Expenditure Scenario in Context of Five Year Financial Model

C) Provide FY 2018-19 Operating Budget Guidance to Board of Selectmen and Board of Education

Motion: A motion was made by Mike Malloy and seconded by Dave Kilbon to direct the BOS to provide a 2018/19 budget incorporating a 1.5% increase over the current year budget and the BOE to provide a 2018/19 budget incorporating a 1.5% increase over the current year budget. Two votes were in favor (D. Kilbon, M. Malloy) and three opposed (O. Davis, J. Francoline, L. Sandora). Motion failed.

Motion: A motion was made by Lee Sandora and seconded by Jim Francoline to direct the BOS to provide a 2018/19 budget incorporating a .75% increase over the current year budget and the BOE to provide a 2018/19 budget incorporating a .75% increase over the current year budget. Three votes were in favor (O. Davis, J. Francoline, L. Sandora) and two opposed (D. Kilbon, M. Malloy). Motion carried.

D) Provide Elected Officials' Salary Guidance to Board of Selectmen

Motion: A motion was made by Mike Malloy and seconded by Dave Kilbon to increase the Selectman's salary to \$78,155 and increase the Registrars' salary to \$8,020. Two votes were in favor (D. Kilbon, M. Malloy) and three opposed (O. Davis, J. Francoline, L. Sandora). Motion failed.

Motion: A motion was made by Lee Sandora and seconded by Jim Francoline to increase the Selectman's salary to \$77,600 and increase the Registrars' salary to \$7,960. Four votes were in favor (O. Davis, J. Francoline, M. Malloy, L. Sandora) and one opposed (D. Kilbon). Motion carried.

E) Review and Respond to BOE Non-Educational Expenditure Estimates (PA 13-60)

Sue Greco indicated she would get the information to the BOF after the next BOE meeting on February 12th.

F) Discuss and Act on Boards of Selectman Capital Request

Motion: A motion was made by Lee Sandora and seconded by Jim Francoline to recommend for Town Meeting action a sum not to exceed \$75,000 from the Capital Non-Recurring Fund for Phase II of the Revaluation project. Any unexpended funds are to be returned to the Capital Fund. **All votes were in favor and the motion carried.**
