## 1) Call to Order

A regular meeting of the Board of Finance was called to order by Chairman Dave Kilbon at 7:34 p.m. Members present were alternate Oliver Davis, Jim Francoline, Mike Malloy, Dave McNally, Mark Porter and Lee Sandora.

## 2) Election of Board of Finance Alternate

A nomination was made by Mike Malloy and seconded by Dave McNally to designate Natalie Welsh as BOF Alternate. There were no further nominations.

The voting results were unanimous. Natalie Welsh was elected as board alternate. Natalie was then sworn in by Jim Hayden.

# C) Provide FY 2019-20 Operating Budget Guidance to Board of Selectmen and Board of Education

Motion: A motion was made by Mark Porter and seconded by Dave McNally to direct the BOS to provide a 2019/20 budget incorporating a 1.5% increase over the current year budget and the BOE to provide a 2019/20 budget incorporating a 1.5% increase over the current year budget. Three votes were in favor (Kilbon, McNally, Porter) and three opposed (Francoline, Malloy, Sandora). Motion failed.

Motion: A motion was made by Lee Sandora and seconded by Jim Francoline to direct the BOS to provide a 2019/20 budget incorporating a 1% increase over the current year budget and the BOE to provide a 2019/20 budget incorporating a 1% increase over the current year budget. Four votes were in favor (Francoline, McNally, Porter, Sandora) and two opposed (Kilbon, Malloy). Motion carried.

### D) Provide Elected Officials' Salary Guidance to Board of Selectmen

**Motion**: A motion was made by Mark Porter and seconded by Jim Francoline to increase the Selectman's base salary to \$71,000. **All votes were in favor and the motion carried.** 

**Motion**: A motion was made by Mark Porter and seconded by Mike Malloy to increase the Registrars' salary to \$8,600. **All votes were in favor and the motion carried.** 

**Motion**: A motion was made by Mike Malloy and seconded by Mark Porter to add "Consideration of BOF Budget for FY 20" as agenda item 6E. **All votes were in favor and the motion carried.** 

## E) Consideration of BOF Budget for FY 20

**Motion**: A motion was made by Mike Malloy and seconded by Mark Porter to present a BOF FY20 budget of \$1,700 (no increase from the prior year). **All votes were in favor and the motion carried.**
