**Motion:** A motion was made by Dave McNally and seconded by Lee Sandora to accept the minutes of the January 21, 2020 meeting. **All votes were in favor and the motion carried.**

# 5) <u>Unfinished Business</u>

# A) Status FY 2018-19 Audit

Natalie Welsh indicated the BOE completed their work and the auditors are now finishing their work. The auditors anticipate being complete by 2/21. The OPEB report is anticipated to be complete by the end of this week.

# A) Review 2019 Grand List Data

The 2019 Grand list was reviewed. Natalie Welsh noted that the net Grand list decreased slightly from the prior year. Mary Ellen Brown discussed some of the items that affected the Grand list data.

# C) Provide FY 2020-21 Operating Budget Guidance to Board of Selectmen and Board of Education

**Motion:** A motion was made by Mike Malloy and seconded by Natalie Welsh to direct the BOS to provide a 2020/21 budget incorporating a 2% increase over the current year budget and the BOE to provide a 2020/21 budget incorporating a 2% increase over the current year budget. **Four votes were in favor (Malloy, McNally, Porter, Welsh) and two opposed (Francoline, Sandora). Motion Carried.** 

#### D) Provide Elected Officials' Salary Guidance to Board of Selectmen

**Motion**: A motion was made by Mike Malloy and seconded by Dave McNally to increase the Registrars' salary to \$9,000. All votes were in favor and the motion carried.

**Motion**: A motion was made by Jim Francoline and seconded by Lee Sandora to add an additional step to the First Selectman's salary grid of \$1,000 for a seventh term. Four votes were in favor (Francoline, Malloy, Porter, Sandora) and two opposed (McNally, Welsh). Motion Carried.

The BOF indicated they would like to revisit the First Selectman's salary at the next BOF meeting.

**Motion**: A motion was made by Lee Sandora and seconded by Mike Malloy to add "Consideration of BOF Budget for FY 21" as agenda item 6E. **All votes were in favor and the motion carried.** 

#### E) Consideration of BOF Budget for FY 21

**Motion**: A motion was made by Mike Malloy and seconded by Jim Francoline to present a BOF FY21 budget of \$1,700 (no increase from the prior year). All votes were in favor and the motion carried.

**Motion**: A motion was made by Jim Francoline and seconded by Dave McNally to add "Review and Discuss BOE non-educational costs (P.A. 13-60)" as agenda item 6F. **All votes were in favor and the motion carried.** 

# F) Review and Discuss BOE non-educational costs (P.A. 13-60)

The draft of the BOE non-educational costs and the format were reviewed and discussed. Ray Engle indicated he would have the final version to the BOF by 2/21.
