Jim noted the areas that East Granby has shared services and highlighted the increases/decreases in specific line items. He also noted some items that will need additional resources in the future.

BOE Chairman Bob Paskiewicz presented a BOE approved operating budget proposal of 2.33%. He indicated that in order to get to the 2% budget as requested by the BOF, the BOE would reduce staffing.
