**Motion**: A motion was made by Mike Malloy and seconded by Jim Francoline to direct the BOE to present a budget of \$19,142,402 at the public hearing on April 18, 2023. **All votes were in favor and the motion carried.** 

**Motion**: A motion was made by Jim Francoline and seconded by Todd Zessin to direct the BOS to present a budget of \$5,434,915 at the public hearing on April 18, 2023. **All votes were in favor and the motion carried.**
