They noted and highlighted several of the budget drivers as well as some of the budget lines that had cost savings. They indicated that in order to reduce the budget to the 3.5% increase as requested by the BOF they would need to reduce staff.

BOE Chairman Bob Paskiewicz and Superintendent Missy Bavaro presented a BOE operating budget proposal of 5.25% as requested by the BOF. The superintendent recommends a budget proposal increase of 7.89%. At the 5.25%, the BOE would look to reduce in several areas including staffing, athletics and after school programs.
