



BOARD OF SELECTMEN MEETING MINUTES
Wednesday October 9, 2024
Town Hall Meeting Room – 6:30 PM

1. **CALL TO ORDER** – A meeting of the East Granby Board of Selectmen (BOS) was held on Wednesday October 9, 2024 at the Town Hall Meeting Room. First Selectwoman Wimpfheimer called the meeting to order at 6:30pm. Selectman Hall and Selectperson Thompson were present.
2. **PUBLIC COMMENT** – First Selectwoman Wimpfheimer read an email regarding a Residents concern on creating a Noise Ordinance.
