SOCIAL SERVICES UPDATE

Granby has a grief loss program and a healthy minds program that residents may participate in.

GOOD SAMARITAN PROGRAM

Matches included transportation, yard work, housekeeping, and home repair. Eight businesses (the same as 2014) were available to assist.
