# TOWN & SCHOOL BUILDING COMMITTEE MINUTES SPECIAL VIRTUAL MEETING October 15, 2020 – 6:30 pm

 CALL TO ORDER -- A virtual meeting of the East Granby Town & School Building Committee was held via Zoom. Chairman Jim Hayden called the meeting to order at 6:33 pm. He stated that once submitted, the State will conduct its review, which may include asking questions for him to answer about the project; and at the conclusion of the review, release their final project reimbursement to the Town.
- c. **Project Update Roads** J Hayden stated that the work on Glen Hollow, Eastfield Farms Drive, and Wintergreen Lane is expected to be completed by the end of next week. This work will conclude the road work for this year, which is year two of five; and would complete eleven of the twenty-two miles of work planned for the project. Currently the project is ahead of schedule.
- **d. Project Update Allgrove Air Conditioning/Electrical Upgrade** R LaFleur stated that KSE Inc, which is doing the electrical upgrade, has received the

information they need from Eversource and he is awaiting confirmation of approval from BVH, the designer of the main electric distribution panel.

R Carlson submitted data for the Committee to consider before making their decision concerning which air conditioning unit option will be installed. There was some discussion of this data. No decisions were scheduled or made.
