TOWN & SCHOOL BUILDING COMMITTEE MINUTES SPECIAL VIRTUAL MEETING October 29, 2020 – 6:30 pm

1. CALL TO ORDER -- A virtual meeting of the East Granby Town & School Building Committee was held via Zoom. Chairman Jim Hayden called the meeting to order at 6:32 pm. In attendance were Jim Hayden, Bob Ravens-Seger, Tim Butler, Jim Velleman, Rick Granger, John Ziobro, and Mike Malloy.

Also present were Roger LaFleur, Project Manager, Superintendent Melissa Bavaro-Grande from the Board of Education, and Ray Carlson, Facilities Supervisor.

- **a. Project Manager Report** R LaFleur stated that he and M Bavaro-Grande met to prepare and send paperwork concerning the Allgrove and Middle/High School roof projects to the State Department of Education.
- **b.** Project Update Roofs R LaFleur stated that all roof projects are complete.
- c. **Project Update Roads** J Hayden stated that all paving has been completed for this year, which is the second year of the five year project. Paving is ahead of schedule, with eleven of the planned twenty-two miles completed. During the winter, there will be a review of the roads not on the remaining planned list to determine if any should be added.
- **d. Project Update Scour** J Hayden stated that Wengell, McDonnell & Costello (WMC), which was awarded the Request For Qualifications (RFQ), reduced their price by \$4,500.
- e. Project Update Allgrove Air Conditioning/Electrical Upgrade R Carlson stated that the electric work will be started next week. The necessary equipment has been ordered and is expected to be installed and ready for Eversource to proceed by the beginning of next year.

The Committee continued to review the data from R LaFleur and R Carlson concerning the types of unit options and their costs. No votes were planned or taken.
