## TOWN & SCHOOL BUILDING COMMITTEE MINUTES

# SPECIAL VIRTUAL MEETING November 4, 2021 -- 6:00 pm

1. CALL TO ORDER -- A virtual meeting of the East Granby Town & School Building Committee was held via Zoom and call-in. Chairman Jim Hayden called the meeting to order at 6:08 pm. In attendance were Jim Hayden, Bob Ravens-Seger, Tim Butler, Rick Granger, and Mike Malloy.

- **b.** Project Update Floydville Scour Remediation—J Hayden stated that the tests have been completed with no problems detected; and there are no mussel issues. The final approval from the State is expected. Work can begin in 2022.
