CONSERVATION COMMISSION INLAND/WETLANDS AGENCY EAST GRANBY, CONNECTICUT March 1, 2017 Minutes

A meeting of the East Granby Inland Wetland/Conservation Commission was held on Wednesday, March 1, 2017. Members present when Chairman George Cornelius called the meeting to order at 7:01 p.m. were John Rusnock, Daniel Methot, Michael Malloy, John Febbroriello and with alternate members Russell Houghton and Jennifer Frank.

DISCUSSION WITH PUBLIC

A. Timothy Brignole – wood chips@ Creamery Brook

Mr. Brignole was not present. See "Director of Community Development Report"

NEW BUSINESS

A. DSGT, LLC - 3 Creamery Brook/regulated activity/new office building (CC17-01) (rec'd 2/01/17) (d/d 4/05/17)

Guy Hesketh, applicant & engineer for the project, discussed the plan details. He was combining the remaining 2 lots in the Creamery Brook subdivision which are currently vacant and planned to build a new office building. The total acreage combined is 1.18 acres with .2 acres of wetlands and .56 acres of disturbance in the upland review for a pipe into wetland soils for a footing drain.

Mr. Hesketh discussed the building elevations with plans for a full basement. He wants to remove additional fill stored 15 years ago on the lots by a previous owner and re-grade. All utilities are existing. He discussed sedimentation and erosion controls, paving and parking. He also reviewed the history of the property since the 1989 subdivision. Wetlands were flagged at that time and his maps reflected that determination.

Mr. Haynes reviewed his comments and that of the Town Engineer. The applicant had no issues with revising the maps to meet those recommendations. The Commission had questions regarding the flood plain, curbing, sheet flow and sanitary sewer easements. Upon discussion with regards to fertilizers and herbicides and "no mow" areas, the applicant agreed to a 25 ft. no mow area and a note will be added regarding the use of organic based fertilizers and natural seed mix. These will be added as conditions of approval.

A motion was made by George Cornelius and seconded by Frank Kilby to approve Application #CC17-01 by DSGT, LLC for a regulated activity for property at 3 Creamery Brook to construct a new office building subject to the following conditions:

- 1. Plans shall be revised to include the comments listed in the Town Engineer's Report dated 2/27/17 #1 #6
- 2. Revise the plans to pull proposed grades outside of the wetland area.
- 3. Revise the plans to eliminate two (2) parking spaces on western most side of proposed building.

- 4. Revise the plans to add the wetland approval block.
- 5. Revise the plans to add hay bales/silt sock on the downslope portion, where the brook runs parallel with proposed silt fence, to help ensure erosion and sedimentation control measures.
- 6. Revise the plans to add a twenty five (25) foot natural buffer around the wetland area near the brook as an additional condition required by the Commission.
- 7. Revise the plans to add a note regarding the use of organic based fertilizer and naturalized seed mix (with no use of herbicides) as an additional condition required by the Commission.
- 8. Prior to any site disturbance applicant E&S measures shall be installed and inspected by the Wetland Enforcement Officer.

Votes in favor were unanimous. Motion carried.

A motion was made by Michael Malloy and seconded by Frank Kilby to approve the minutes of December 7, 2016 with one correction: - the date at the top of page 1; change 2017 to 2016. The votes in favor were unanimous. Motion carried.
