They explained the way the regulation was crafted it would ensure other gas station would be limited as they would only be allowed to be a certain distance from existing stations and located at lighted intersections.

A motion was made by John Ziobro and seconded by Gary Vick to write a memo to the PZC commission prior to the 3/8/16 public hearing date to support the regulation change as presented by the applicant with the limiting language keeping separation distance and number of potential locations on Rte 20. Votes in favor were unanimous. Motion carried.

Brignole Winery-113-115 Hartford Ave, taken out building permit to construct 14 k sq ft winery. Building Permit has been issued. Framing complete working on interior/mechanicals.

<u>Z Parking</u>-3 International Dr, taken out building permit to install entrance and exit gates to help improve efficiency of the valet parking.

<u>F&L Construction</u>-9 South Main St, has taken out tenant fitout for 2^{nd} floor dentist office to be changed to (2) one bedroom apartments.

<u>Phillips 66 Gas Station</u>-150 Rainbow Rd, has taken out tenant fitout to expand deli into full restaurant.
