<u>103 Hartford Ave</u>- Received text amendment to Zoning Regulations to allow winery to apply for Craft Liquor Permit. Which would allow them to sell other products other than wine. Application was approved at the March PZC Meeting.

50-58 Rainbow Rd- Silverman Group submitted regulation change for Commerce Park Transitional Zone along with concept plan displaying their plans for development of the 130 acre parcel behind the Route 20 plaza. The public hearing is scheduled for 4/12/22 PZC Meeting.
