MINUTES East Granby Parks & Recreation Commission East Granby, Connecticut February 3, 2022

1. CALL TO ORDER

A regular meeting of the East Granby Parks & Recreation Commission was held Thursday, February 3, 2022 at the large conference room at the East Granby Town Hall. 5. PROGRAM DIRECTOR'S REPORT

Director A Van Neil stated that all her programs are going very well. Attendance is full or nearly full, and coaches for programs like youth basketball are plentiful. All programs are back in person.

D Jacius stated that the part-time salary portion of the budget is the last item on which work is being done to complete it for a full review.

7. OLD BUSINESS

A. Committee Reports

- 1. Farmington Valley Heritage Trail B Ravens-Seger stated that he walked the north portion of the Trail and saw many footprints indicating use. He did not see any snowmobile tread marks. Somebody plowed north of Copper Hill Road again. A Van Neil stated that she will bring this to the attention of the DPW.
- 2. Cowles Park D Jacius stated that the Park was being well used by fat bikes until the ice storm. Eversource has begun the clearing of their line areas which, while not in the Park, are adjacent to it. They are staying in touch with her about the project, and will endeavor to not be disruptive to Park use.
- **3. Granbrook Park** J Brady stated that he has observed that much of the current use of the Park is by dog walkers.

Halloween – October 29 5:00 pm start at Newgate Prison Tree Lighting – December 2 6:00 pm start Drive-in Movies – decisions yet to be made

N Sokolowski stated that she would like to investigate the cost of acquiring non-flammable luminaries to use as street and driveway liners at the Tree Lighting. These areas of the Town Hall Campus are very dark after sundown and the luminaries would be helpful to the many pedestrians who attend this event. They would also be a beautiful addition to the lighting festival itself. Commission members thought it was a good idea. She will investigate and report back at a future meeting.
