Requirements for Application Approval:

1. Submission of site plan, installation details and specifications. For Site Infrastructure and Public Sewer Extensions drawings are to be prepared and sealed by a Registered Connecticut Professional Engineer.
2. Applicant shall pay DESIGNATED FEE AS SHOWN ON PAGE 1 and pay retainer of \$3,000 to cover cost of plan review and inspections. Any part of the retainer that is unused will be turned back to applicant after final approval has been given by Town Engineer. If retainer is fully expended the Town can require applicant to submit additional funds to cover cost of necessary engineering services to cover cost of additional plan review and inspection services.
3. A complete schedule of process and industrial wastes including daily and maximum hourly discharge rates. DEP Permit (or application therefore) must be submitted.
4. Furnish any additional information relating to the installation of use of the sewer requested by the WPCA or Town Engineer.
5. Except as otherwise approved by the Town Engineer the design, installation and testing of all sewer lines, manholes and appurtenances are to comply with the Standard Specifications and Details of the Metropolitan District Commission (MDC), latest edition. All work within the public ROW is to comply with the requirements of the Town of East Granby and the Connecticut DOT, as applicable.
6. Operate and maintain any waste pretreatment facilities as may be required as a condition of the acceptance into the public sewers for industrial and process wastes at no expense to the Town.
7. Notify the WPCA immediately in the event of any accident, negligence, occurrence that occasions discharge to the public sewers of any wastes not covered by this permit.

Requirements after Approval:

1. Pressure testing is required on all new sanitary sewer pipes installed.
2. Vacuum testing is required on all new sanitary sewer manholes only
3. Submission of As-Built drawings (to include plan and profile) and AutoCad digital files (Y) or (N) within 30 days of completion of work.
4. Coordinate inspections of sanitary sewer system installation with the Town Engineer.
