### **WHAT IS DUE NOW?**

- **2<sup>ND</sup> Installment of Real Estate Taxes**

The bill was included with the bill you received in July. It can also be found online at:

**Payment is due no later than FEBRUARY 3<sup>RD</sup>**

Did you recently pay off your mortgage and have not received a tax bill? Please notify the Tax Office immediately. Do not rely on your mortgage company to notify us. If you are responsible for the January installment, this payment is due by February 3<sup>rd</sup>. Per Connecticut State Statute 12-130 failure to send or receive a tax bill does not invalidate the tax.

- **Supplemental Motor Vehicle Tax Bill** (*NOT EVERYONE RECEIVES THIS BILL*)

These were mailed on December 26<sup>th</sup> to anyone that registered a vehicle between October 1, 2023-September 30, 2024. Anyone that had a registration that lapsed prior to October 1, 2023, and did not renew until after October 1, 2023, and before September 30, 2024, should also have received a supplemental motor vehicle tax bill because they did not receive a bill in July 2024.

### **Payment Options**

**Pay Online** (*fees do apply*) at <https://eastgranbyct.org/tax-collector/>

The most affordable online option is to pay by E-check. It is only \$0.95 for your entire transaction!

**Pay by phone – automated** (*fees do apply*): 1-833-317-4232

This is an automated system, you will need your bill number (EX: 2023 04 1234567) and amount due.

**Pay in office:** 9 Center Street, East Granby **Hours:** Monday-Thursday 8-12, 1-4 (closed 12-1) Friday 8-1

**Dropbox (24/7):** Located outside of building (side facing Senior Center) Checks only – **NO CASH**  
**(Payments must be in drop box by 4:00 p.m. Monday, February 3<sup>rd</sup>)**
